Vantage Towers employees join forces across 8 countries to plant trees and strengthen global commitment to sustainability, helping to sequester 67 tonnes* of CO₂.

Düsseldorf, November 13 – Vantage Towers announced the launch of its global tree-planting initiative, uniting employees across eight countries in a shared mission to create a greener, more connected future. This initiative is part of Vantage Towers' Environmental, Social, and Governance (ESG) strategy and reinforces the company's commitment to environmental stewardship, community engagement, and collaborative action.

This week, employees in the Czech Republic, Germany, and Ireland are leading the first round of tree planting activities, followed by colleagues in Hungary, Romania, Spain, Portugal, and Greece in the coming weeks. Together, teams across all eight countries are contributing to a greener, more connected future, reflecting the spirit of collaboration at the heart of Vantage Towers' ESG approach.

Nicolas Mahler, Interim CEO & CFO at Vantage Towers: "With almost 4,000 trees planted – covering more than 15 species from apple to ash – across eight markets, our 300+ participating employees fight against biodiversity loss and climate change, contributing with an expected yearly sequestration of 67 tonnes of CO₂. This initiative shows how our ESG commitments translate into tangible, measurable impact."

Vantage Towers' ESG initiatives are closely aligned with the company's broader purpose: to connect people, empower communities, and enable progress through its telecommunications infrastructure. The tree-planting initiative reflects this mission by demonstrating that Vantage Towers' ESG approach and its impact extend beyond connectivity: building stronger, greener, and more resilient communities while fostering collaboration and innovation.

* The estimated annual carbon sequestration is based on sequestration estimates obtained from local partners and an proxy of 18,4 kg of CO₂ absorbed per tree per year, used to cover existing data gaps. Actual sequestration rates may vary across locations, depending on
